



Keeping the Membership informed, LTBA President Warren J. Harang, III

ver 2500 years ago, the Greek philosopher Heraclitus said, "Change is the only constant in life." That is just as true today as it was then, and applies to our Louisiana Thoroughbred Breeders Association. At the most recent meeting of the LTBA Board of Directors, significant changes to our By-Laws were approved. You can find and read the by-laws through a link on the LTBA Website www.louisianabred.com under the "About Us" drop down menu. Please familiarize yourself with the rules of our organization.

The board recognizes the importance of numbers when the Louisiana Legislature is making decisions that affect our industry. With that in mind, membership has been simplified in order to make joining the LTBA easier and to help grow our organization. The current membership forms were mailed recently and can also be found on the LTBA website. Please note that memberships are due by September 30th. After October 31st the price of dues increases from \$75 to \$85.

Now that the Board of Directors has ironed out the membership details, the next order of business is the 2022 Board Elections. Four members of the current board are up for re-election: Brett Brinkman, Charlotte Clavier, Tom Early and myself, Warren Harang, III. Nominations from the membership are due by October the 10th, with ballots to go out in the mail no later than November 1st. Board members are elected to three year terms.

Following the success of the 2021 Yearling and Mixed Sale, the LTBA is hosting the 2022 Breeders Sales of Louisiana Yearling Sale Followed by Mixed Session on October 1st at the Equine Sales Facility in Opelousas. Catalogs were mailed in late August, and may be found on the LTBA website as well as through The Jockey Club Information Systems' Equine Sales Catalog app for the Ipad. While the consignment deadline has passed, supplemental entries are still being accepted, so don't hesitate to consign your yearlings, horses of racing age or breeding stock. Contact Tom Early (504) 452-8208 directly. And most importantly, come to the sale! Louisiana-breds have been in high demand, and their value is expected to go up along with purse increases anticipated since the passage of legislation last fall.

Since the previous issue of Louisiana Horse, we have had two Louisiana-bred Stakes Days. First, Louisiana Legends Night in June at Evangeline Downs, and more recently, Louisiana Cup Day at Louisiana Downs. The competition was strong and the fans were treated with some exciting races. You can read about each in the pages of this magazine. I am always impressed with the quality of athletes representing our breeding program. Next up, the finale' of our spotlight race days for the year, Louisiana Champions Day at Fair Grounds on December 10th. We are bringing back the Gala the night before. Be looking for more information to come, and I hope to see many of you at both events.

While the 2022 breeding season is finished, it is not too early to start thinking about 2023. Stallion owners can find the Louisiana Horse Stallion Register submission form on pages 9-11 of this magazine.

I encourage everyone to be actively involved in all aspects of our industry. Come to a board meeting; be informed and involved. We at the LTBA are doing all we can to be of service to you, the breeders. If you have any questions about our program, the staff in our office at Fair Grounds is happy to help. I personally am always happy to hear from you, especially with suggestions for improving our program.

### **EL DEAL**


In a state-bred breeding program, a stallion's ability to throw speed and precocity can be the difference between an early, profitable winner and a foal that offers little return on investment. When it comes to that ability, El Deal is showing the signs that he may be the real deal. Last year, he was the Louisiana champion freshman sire of 2021. This year, he has sired 15 winners from 26 runners and as of August 22 is the leading second-crop sire in both the state of Louisiana and the Southwestern region.

PEDIGREI PATTERN

Foaled in 2012, El Deal showed plenty of speed during his own racing days. After winning a 6-furlong maiden special weight at Aqueduct in his only juvenile start, he remained undefeated in three starts at 3. His races that year included allowance wins over 6 furlongs at Aqueduct and Parx Racing, followed by a successful step up to stakes competition in the 6-furlong Gold Fever Stakes at Belmont. Less successful at 4, he won only two of seven starts that year but placed in two sprint stakes.

El Deal put it all together at 5 to show just how good he could be. On April 22 at Hollywood Casino at Charles Town Races, he scorched 4½ furlongs in :50.66 in a handicap race, earning an Equibase speed figure of 123. He followed up on June 11 by winning the Decathlon Stakes at Monmouth by 3 lengths over multiple stakes winner Ostrolenka, with grade 3 winner Always Sunshine and multiple stakes winner Tiger Blood in the beaten field. In that race, he stopped the timer in a smart 1:08.59 for the 6 furlongs.

El Deal then stepped up to grade 1 company in the Alfred G. Vanderbilt Handicap at Saratoga. He faced a salty field that included grade 1 winner Green Gratto, multiple grade 2 winner Limousine Liberal, and four more graded stakes winners, and he proved more than equal to the task. Breaking on top, he made every post a winning one and hit the finish line eight lengths in front. His time of 1:09.26 for the 6 furlongs earned him an Equibase speed figure of 121. He was second in the Vosburgh Stakes (G1) on September 30, going under



by a length to Takaful, and after failing to train satisfactorily for the TwinSpires Breeders' Cup Sprint (G1) was retired. He left racing having won nine of 17 starts and \$575,025.

As a son of Munnings, El Deal comes by speed honestly. A son of 2004 American champion sprinter Speightstown (who has finished nine times among the top 10 sires in The Blood-Horse's rankings, including a second-place finish in 2012), Munnings traces his male line through Speightstown's sire Gone West (himself a highly successful sire) to the great sire of sires Mr. Prospector. Produced from the Holy Bull mare La Comete, Munnings was at his best at 7 furlongs and won three grade 2 stakes over that trip, including a scorching victory in 1:20.63 in the 2009 Woody Stephens Stakes at Belmont. He also placed in six grade 1 events at distances from 6 to 9 furlongs.

At stud, Munnings has lived up to his performance as well as his pedigree, which on his dam's side traces to the great La Troienne family through the Bieber-Jacobs Stable's foundation mare, Searching. The best sire son of Speightstown thus far, he has 60 stakes winners credited to him as of July 8. Those stakes winners include the brilliant 3-year-old Jack Christopher, who one-upped his sire on June 11 by taking the Woody Stephens Stakes (now a grade 1 race) by 10 lengths.

On the distaff side, El Deal was produced from Spirit of Wallea, also the dam of stakes-placed Legacy Wildcat (by Forest Wildcat). Sired by multiple grade 1placed 1991 Clark Handicap (G3) winner Out of Place (by 1978 Metropolitan Handicap, G1, winner Cox's Ridge), Spirit of Wallea is a half sister to multiple grade 2 winner Choctaw Nation (by Louis Quatorze) and to grade 3-placed listed stakes winner Treasured Up (by Medaglia d'Oro). The siblings are out of the winner Melisma (by 1980 Arlington-Washington Futurity, G1. winner Well

Decorated, a half sister to 1994 Beaumont Stakes (G2) winner Her Temper (by Temperence Hill) out of grade 1-placed Marathon Girl (by Fleet Nasrullah). The female line traces back to Nuit de Folies, dam of 1985 American champion broodmare sire Speak John.

El Deal's best runner thus far has been 2021 Louisiana-bred champion filly Free Like a Girl, who is inbred 4x3 to 1994 Horse of the Year Holy Bull as her dam Flashy Prize is a daughter of the grade 1-winning Holy Bull horse Flashy Bull. Free Like a Girl's pedigree also returns Mr. Prospector (via Afleet) and Speak John. The stallion's other stakes winner is True Deal (out of the Big Brown mare Hilarious Brown), whose dam returns Mr. Prospector twice through Forty Niner and the Gone West son Mr. Greeley. Santa Anita maiden special weight winner and Evangeline Downs allowance winner Royal O'Haigain has returns of Mr. Prospector (again through Forty Niner), Storm Cat (the



broodmare sire of Speightstown), and Raja Baba (sire of Well Decorated) on the distaff side of her pedigree. Other elements that appear to work well with El Deal include Danzig and returns of Mr. Prospector through daughters.

In conformation, El Deal is a lengthy, muscular, masculine individual with correct legs, a powerful body, and very strong hindquarters. "He puts that big rear end on his foals, and if you give him a mare that's a little rangier, she can put more leg into them and not lose that power," says Red River Farms's Jay Adcock. "The great thing is that he's got all that speed, but he's been turning out some babies that can run routes too. He bred the most and best mares he's had yet this last season, and I'm looking forward to seeing their babies."

El Deal stood the recently concluded 2022 season at Red River Farms for \$2,500.



horse like this," said Cotto. "We struggled a little out of the gate, but when I asked her, she responded. She is so fun to ride. You never have to worry about the competition when you ride her, only you and the filly."

Free Like a Girl is now 7-13 lifetime with a \$401,473 bankroll.

"We knew she would be sharp because she's been on her toes for

the last month," said Chasey Deville Pomier. "We knew what we had to do to win the race and she did it. It was really fun to see her come back to Louisiana and race again."

From gate-to-wire, Big Chopper led all the way with fractions of 24.01, 47.83 and 1:11.93 before stopping the clock in 1:37.71 at a mile to beat a game Vodka Gimlet by a half-length.

"He broke so well I really didn't have to do much," said jockey CJ McMahon. "He was impressive today. We had to dig in a little, but he was much the best."

It was really touch and go, but he made it. He came back to the farm and I got really close with him. I was able to see him win his first race at the Fair Grounds and now see him win a stakes race. What a true warrior he is."

Maher also explained that Big Chopper's owner Kendel Standlee is amazing. "He truly loves each and every horse he owns," she explained. "We need more owners like him."

Big Chopper (\$13.80) improved to 3-8 with earnings of \$130,480 and will be given the rest of the summer off, said Gelner.

"I'm really lucky to train a good horse like her," said Landry. "She is really special."

Net a Bear is a multiple stakes winner yet was coming into Louisiana Legends Night with a two-race losing streak. Piloted by Tim Thornton, the two were "unhurried" out of the gate and sat perfectly behind a wall of horses that included Sumitup who set fractions of 23.63 and 48.15. A new leader took over in World War, which looked to give Ron Fauxheux and Jareth Loveberry their third stakes win on the card, but the daughter of Awesome Bet weaved through traffic then patiently waited for an opening before she found new energy to win by nearly 2 lengths in 1:36.91. "We had a little traffic trouble, but she did a good job with it," said Thornton. "She had a lot left in her. Once we found a crease, it was all but over."

Winning for the 12th time in 33 career starts, Net a Bear increased her earnings to \$615,970 and returned \$3.40 to those who backed her to win.

Sharp away from the gate with Jareth Loveberry in the irons, Bertie's Galaxy was quickly in charge and did his own thing in 21.86 and 44.63. As a few rivals tried to make a race of it, Bertie got stronger and extended his lead to win by 2 1/4 lengths to cover 5 1/2 furlongs in 1:03.52.

"This horse is just so consistent," said Faucheux. "Jareth fits him like a glove and gets along with him so well. I like the way he gets better each race, and you want to see that in every horse." Faucheux also explained that Bertie's Galaxy was a handful when he was young.

"He had problems getting into the gate," he said. "It took us about a year for him to be comfortable in the gates. I thought once he matured, he would turn into a good horse and he is getting there. He is very interesting horse... he is reluctant to switch leads, when he does he tends to level off."

Off as the 2-1 favorite, Bertie's Galaxy (\$6.60) improved to 11-25 for earnings of \$442,950 for owner Allen Cassedy.

Maga Man won this same race last year with different connections on a muddy dirt surface. This year he returned to the turf, but this time with jockey Joe Stokes and trainer Norman Miller III, to win an exciting Louisiana Legends Turf race.

"There was a lot of speed in the race," said jockey Joe Stokes. "The horse was able to relax off the pace and just have a perfect trip. I asked him and he responded very confidently."

The 7-year-old gelded son of

Musket Man showed his versatility by sitting off the early speed burners like Forestdungone, Mangelsen and Behemah Star, who set a swift tone of 23.21, 47.28 and 1:11.63. Stokes and Maga Man then launched a four-wide rally and dug in to catch Jaci's Royalty to win by a 1/2-length to cover in 1:43.33.

"I told Joe before the race to take the horse back and it worked," said winning trainer Norman Miller III. "Joe really did a tremendous job with him."

Miller recently came out of

retirement. Many remember his big horse Bonapaw, a multiple Grade 1 winner with earnings of more than \$1.1 million. Miller was content playing tennis, but his son, Norman C. Miller IV, wanted to claim a horse and have his father train it. So the two sought out Maga Man and nabbed him for \$20,000 last March at the Fair Grounds in New Orleans.

"We knew he liked the turf," said Miller. "We raced him a few times to see what we had and were able to fix some issues. We took the blinkers off and he ran a big race for us."

Miller said it was emotional to step back into training horses in Louisiana after his previous success. "My good friend and fellow trainer Glenn Delahoussaye called to congratulate me and it really brought me to tears," said Miller. "This is the only horse I am training, so we will give him the summer off and find a race for him in September."

Sent to the gate at 7-1 odds, Maga Man returned \$17.20 to his bettors. The running improved to 10-39 with earnings of \$369,880.



# FILL YOUR LOUISIANA CUP

If you revitalize it, they will come. The once storied Louisiana Downs in Bossier City has begun to return to its glory days thanks to new co-owner and president Kevin Preston, who took over last November. The changes made in a short period of time were made prevalent with full fields during Louisiana Cup Day on Aug. 6 as six stakes races totaling more than \$400,000 in purse money saw plenty of exciting action as some new and some familiar faces returned to the winner's circle to claim a coveted cup.

All eyes were on the overwhelming betting favorite, King's Lute. The second-time starter for Carl Woodley was a dominant winner in his debut against open bred company in June at Louisiana Downs, but a difficult rail draw and a game opponent in Bisping was too much for him to overcome in the 12th running of the Louisiana Cup Juvenile.

The eight-horse field was full of talent as 32-1 longshot Easy Chance led most of the way setting fractions of 23.83 and 46.49. Bisping with pilot Devin Magnon were never far from the leader and able to make a move on the inside to rumble by Easy Chance and draw off to cover 5 1/2 furlongs in 1:05.90 and win by nearly 4 lengths.

"This is a very professional horse," said Magnon. "I stayed on the inside of the track and never had to take behind a horse. He started tugging me around the turn, so I let him go. He isn't the fastest horse,



but he does everything you ask."

Owned by Anna Guillot, the 2year-old gelded son of El Deal returned to Louisiana after a sixthplace finish in the \$150,000 Tremont Stakes against open company at Belmont Park.

"He showed us he was really talented after his debut at Evangeline Downs," said winning trainer Ricky Courville. "I hauled him up to Louisiana Downs the night before to beat the heat and he had no problems settling in."

Courville added that Bisping will head to the D.S. "Shine" Young Memorial Futurity at Evangeline Downs.

Bisping (\$9.60) improved to 2-3 with earnings of \$58,050.

When you're hot, you're hot. No horse on the Louisiana Cup Day program has been more dominant in their last several starts than Cheapskate Diva. The daughter of Animal Kingdom has literally destroyed her competition in her last three starts winning by a combined 18 lengths and she is now a turf stakes winner after a crafty ride by jockey Carlos Marquez in the 37th edition of the Louisiana Cup Distaff.

"She used to run off on me, but she is now able to relax, and that's because Joseph Felks has done a great job with her," said Marquez. "When you ride a good horse, it will make the jockey look really good. She did it easy for me today."

Longshot Visionofwildtimes took the early lead hitting fractions

of 23.77 and 48.39. Marquez confidentially placed his horse right behind the leader, then drew clear at the top of the stretch to hold off Fort Polk by a 1/2 length in 1:41.92.

Trainer Joseph "Bobby" Felks, a man of few words, did acknowledge the great ride and owners for the accomplishment, following his first stakes win.

Cheapskate Diva (\$9.80) now has four wins in nine starts with earnings of \$101,740 for owner and breeder Keith Plaisance. "Bobby thought it was a good spot to put her in," said Plaisance. "And he was right. She ran a big race today against a lot of tough competition."

Net a Bear, the post-time favorite and defending champion who was starting in her 20th career stakes, finished seventh. Trainer Allen Landry felt the heat might have taken its toll on his multiple-stakes winner. "We are definitely going to give her some time off," said trainer Allen Landry. "She was sweating when we hauled her up this morning. She deserves some off time."

Drop Dead Sexy tried to steal the 40th Louisiana Cup Filly and Mare Sprint by going gate-towire, but she was unable to hold off Free Like a Girl, last year's 2-yearold champion filly, who managed to

put together another exceptional business-like performance to win her seventh stakes race.

Jose Guerrero shipped Drop Dead Sexy to blazing early fractions of 22.33 and 45.30. The early pace was so fast, it allowed for less clumping of horses and helped Free Like a Girl to avoid any traffic problems along the rail.

As the champion and Pedro Cotto Jr. neared the 1/8th-pole, the



race was all theirs. She darted off to win by more than 6 1/2 lengths to cover the 6-furlong distance in 1:10.69 and returned supporters \$4.20.

"She really likes another horse to run at," said trainer Chasey Pomier. "It honestly just played out to her running style and was a perfect trip. We were facing a lot of good older horses here, but she's such a gusty filly. She loves to race."

Free Like a Girl returned to Louisiana after a third-place finish

in the Grade 3, \$225,000 Iowa Oaks on July 9 at Prairie Meadows. She improved to 8-15 with a career bankroll of \$464,073. All of wins have come with Cotto in the saddle.

"He rode for my dad when I was a kid and worked this filly as a baby," said Pomier. "He fits her and does a great job with her."

Cotto added that Free Like a Girl is fun to ride. "She is so professional," said the jockey. "She really does everything you ask her to do. Today, we had a fast pace and we were able to save ground on the inside. Once I asked her, she took off as usual. Another great performance."

Poimer stated that the connections nominated the filly for the Grade 3, \$500,000 Charles Town Oaks.

Trainer Eduardo Ramirez was one of 12 trainers who put in a \$20,000 claim on 5-year-old City Park in February at the Fair Grounds in New Orleans. Despite not winning since last December, Ramirez saw potential in the gelded son of Temple City and that potential turned into the horse's first career stakes win in the 37th Louisiana Cup Turf Classic.

Mangelsen and Big Chopper did most of the work in the 1 and 1/16th-mile affair. The two were likely too quick for their own good with rapid fractions of 23.13 and 46.21. With the pace so swift, the field was strung out, which helped City Park save even more ground on the rail.



Sitting eighth at the half-mile pole, Joel Dominguez made his

move taking a four-wide approach as he mowed down seven horses to

win handily by 1 3/4 lengths in 1:41.23.

"You can always make it happen when you are on the right horse and I had the right horse today," said Dominguez. "The race set up well. I knew if they went fast up front, he would come running and that's what happened."

Owned by MAT Investments, LLC, City Park exited a seventhplace finish in the John Henry at Evangeline Downs last month.

"This is a hard horse to maintain," said Ramirez. "We have tried to put him in a couple of claiming races, but the horse kept improving. Joel did a tremendous job saving ground and he closed really well."

City Park was bet down from his 12-1 morning line and rewarded his backers with a \$12.80 win payout. He improved to six wins in 31 starts for \$210,484.

In one of the most competitive fields in the 12 years of the Juvenile Fillies, the race featured six horses that won impressively in their first start of the young careers.

Saddling her second stakes win on the Cup Day program, trainer Chasey Pomier quickly ran down the stairs to check on the 2-year-old daughter of Custom For Carlos after an interesting finish.

"She's an aggressive filly, but I had never seen her do that before," said Pomier. "She's usually a straight arrow. I wasn't sure we had won yet, but I saw our jockey (Vincente Del-Cid) smiling on the way back so I knew she was fine."

After a third-place maiden start at Churchill Downs, Janet Is Ready won her next start at Evangeline Downs then earned her first trophy in the \$100,000 Prairie Gold Lassie Stakes at Prairie Meadows on July 8 at 21-1 odds.

Del-Cid and the filly broke on

top and won in gate-to-wire fashion. She set fractions of 22.30 and 46.03, then drifted late down the stretch as Guitar Woman chased, but finished a length behind the leader, as the race was clocked in a time of 1:05.65.

"She was all good," said Del-Cid. "She drifted, but we won the race. She is still a young horse."

Pomier knew she had a talented runner on her hands after the first few works.

"Janet worked with Free Drop Maddy, so we knew how competitive she was early on," she said. "If she lost one work, the next week she would come back stronger. She isn't the biggest filly, but once she gets moving, she will make you work for it."

The strong 7-5 favorite Lady Flurry, who was a nine-length winner in her debut June 20, rallied to finish sixth.

Owned by Gerald Bruno Jr., Our Streaks Stable LLC & Jerry Caroom, Janet Is Ready (\$13.20) has won three of four races for \$121,000 and will next compete in the filly division of the D.S. "Shiny" Young Memorial Futurity at Evangeline Downs.


Takes Two to Tango (\$7.80), who won for the fifth time in seven starts at Louisiana Downs and six-




for-16 overall for \$164,190, had no issues with the field with a 3 1/2-length victory covering the distance in 1:10.80.

After last year's success, the banquet was once again paired with a fundraiser to benefit REAP.

## 2021 LOUISIANA HORSE OF THE YEAR CILLA

Cilla, was selected as 2021 Louisiana Horse of the Year from among the Louisiana divisional champions by the Louisiana Thoroughbred Breeders Association Board of Directors.

Cilla, is proof positive that Louisiana-breds can compete among top company anywhere.

After winning the 2021 Louisiana Legends Mademoiselle at Evangeline Downs in June, Cilla took her show on the road to Monmouth Park where she annexed the Blue Sparkler Stakes getting the five and a half furlongs in 1:03.07 to win by 2 1/2 lengths. Next, Cilla won the G2 Prioress S. at Saratoga, running the six furlongs in 1:10.05, defeating Kentucky bred G3 Stakes Winner Souper Sensational. For the year the filly won four of eight starts and earned \$310,600.

Cilla, whose name in Welsh means "venerable" is certainly fulfilling her namesake. In 2022, she has added stakes wins in the Orleans S. and LA Bred Premier Matron, both run at Delta Downs. Cilla's lifetime earnings sit at \$484,000 with more to come.

# Racetrack Employee Assistance Program By Jane Nicholes

No one gets rich as a racetrack groom. The job is essential to the well-being of the horses, but the hours are long, the pay is low and it can be easy for people to grow isolated. The backside of a racetrack is designed for the comfort and convenience of horses, not people.

That's why the Racetrack Employee Assistance Program (REAP) makes such a difference at Evangeline Downs. Something as simple as a laundry facility means a lot to someone whose job mandates getting dirty on a daily basis, but who lives in a dorm room or a tack room and may not even have a car. A church service held in a doublewide trailer just outside the track gates on Mondays or Tuesdays may be the only option for a groom working seven days a week with half a day off. And an illness or injury can quickly devastate a family financially.

REAP helps the backside employees who work for individual trainers, the racetrack's own employees and occasionally casino workers at the racino in Opelousas. There is little formality about the program; problems may come to its attention by word of mouth or a phone call from a donor who's heard of someone who needs help.

"We've done all kinds of things over the years," says Charlotte Clavier, the treasurer of REAP and a board member for the LTBA and the Horsemen's Benevolent and Protective Association. "Wherever we can fill in to help, that's what we try to do."

Dwight Brown is the chaplain at Evangeline Downs. He is also Lt. Dwight Brown of the Opelousas Police Department, and he pastors his own Baptist church unconnected with the track. On-track, he's nondenominational.

"I was a third-generation horse trainer," Brown says. "My grandfather was the first licensed Black horse trainer in Louisiana. His name was Milton Brown. My father's name was Wilbert Brown. He trained horses for 44 years, until he passed away 12 years ago."

Chaplain Brown works closely with REAP, but half his salary is paid by the track and the other half by the HBPA.

"A chaplain is pretty much the caretaker of the backside's needs," he says. "It may be needing someone to talk to, to needing to hear the word of God, to bringing them to get clothes, to providing food, to getting bus tickets."

Well-connected in the community, Brown helps parents with getting their children enrolled in school. He refers employees who may have substance abuse issues to the HBPA counseling program. And if a child gets into trouble, he or she will likely find themselves having to deal with Police Lt. Brown.

The COVID pandemic forced scheduling shakeups in the last couple of years, but before that Brown and REAP bought 100 to 150 backpacks and filled them with school supplies for workers' children going back to school. Brown has done weddings and funeral services when needed. If someone is injured at the track and goes to the hospital, Brown checks on the person and gives him or her a ride back to the track if needed.

But Brown says he gets called most often to help people who have locked their keys in their cars. He can't explain it. "You'd never believe how many people lock their keys in their car."

REAP writes checks to help backside workers pay bills, recover from fires and pay funeral expenses

REAP is available year-round, not just during the Thoroughbred

and Quarter Horse racing seasons. Brown says retired employees and others who just prefer a weekday church service or its informality also visit the trailer on Mondays and Tuesdays. Since it's located outside the track gates, they don't need to be licensed. A woman from one of the local churches conducts the Monday services in Spanish and teaches English as a second language, while Brown handles the Tuesday English-only services. A meal is always served after church.

REAP was founded under the leadership of David Yount, who spent many years in Louisiana

horse racing and was appointed executive director of racing operations before the old Carencro track closed and the new racino opened in Opelousas. REAP was patterned after the Backside Benevolent Fund at Louisiana Downs.

REAP initially was funded with a \$64,000 no-interest loan from the HBPA to set up the trailer and launch the program. Over time, says Clavier, REAP paid the money back.

When Yount passed away after a long illness, former trainer Homer Bourque, a longtime friend of Yount, and his wife Dianne stepped up to lead the organization. Homer Bourque serves as president and Dianne as vice president. Dianne says her husband bought the initial set of machines for the laundry and continues to manage it.

One of the most heartbreaking cases that REAP assisted involved a groom from Guatemala, a man with no green card or passport, who became ill and couldn't continue to work. Dianne Bourque said she and her husband located an air-conditioned tack room where he could stay. Eventually he needed dialysis, so she would drive him to and from his appointments.

Finally, REAP reached out to the Guatemalan Consulate in Houston, which got him a passport and helped him leave the country.

"It was either that or we would have had to bury him here," Dianne says. "He was that sick. He needed to be back with his family. We flew him home and within six weeks he had passed away."

REAP raises most of its money from an annual benefit event, and every cent raised goes to help people. Things have changed in the last few years, apparently for the better.

The 2020 fundraiser was cancelled entirely because of COVID, and the group had to make do with the money they had on hand. Then REAP got together with the LTBA to combine the fund-raiser with LTBA's annual awards banquet at Evangeline Downs.

The plan was intended to boost attendance at both events. LTBA covered the expenses, while REAP offered a reverse drawing and a silent auction. In 2021 attendance was affected by Hurricane Ida, Clavier says.

"I had a call from one guy, and he was sitting in his house with no electricity, but he was still sending me \$100."

This year, with the pandemic on the wane and no natural disaster distractions, REAP raised \$24,000.

Clavier says people who have been helped by REAP try to pay it forward if they can. One man who received assistance after a fire now oversees the cooking at the event each year. Another who received help in REAP's early years later made sure to buy a ticket each year for the reverse drawing. This year the man passed away, but his children bought tickets.

"Our people are good," Clavier says.

# An Apptitude for the **Breeding Business**

Carrol J. Castille - Louisiana Native Astute in Business, Racing and Breeding

Carencro, Louisiana, has been involved with horses since he was a young child. He remembers family trail rides and weekends spent at the bush tracks in Louisiana beginning when he was just 6-years-old.

Maybe it was standing on the rail, close enough to feel the explosive power of horses surging to the wire that ignited a lifelong passion in Castille. Or maybe that his mind worked even faster than the speediest Quarter Horses and Thoroughbreds he admired. That's the mystery, but the reality is that he evolved as a brilliant and innovative businessman. Fortunately for the Louisiana racing industry, his passion for racing and breeding champion Thoroughbreds has never waned.

Castille's first job was on a farm in 1985 and he managed stallions and broodmares for eight years. He enjoyed that but left to pursue a career in the telecom



business. He bought and sold telecom companies, sensing that the curve of the industry would be propelled into a much more sophisticated level. His timing was impeccable and financially stable, Castille bought 125 acres of land in 2000 which he named Whispering Oaks Farm. He envisioned the property as a home for his family with abundant land for horses.

"I built my dream home and decided to run a few horses," recalled Castille. "From there, one thing led to another!"

Understated, to say the least, Castille built a training

track on his property and invested in several other equine businesses, including a feed store and tack shop.

But none of that fulfilled his dream of winning graded stakes and developing a quality breeding program with both stallions and broodmares.

As an owner, Castille had utilized several trainers, but decided he wanted to hire one horseman to oversee his Louisiana-bred runners. His choice was Steve Flint, who had over four decades training Thoroughbreds, begin-

ning with a tenure for the Klein Family prior to assisting Hall of Fame conditioner, Steve Asmussen. He ran strings for Asmussen in Canada, Kentucky and Louisiana. Castille liked the idea of his trainer seeing his homebreds from babies through their racing careers and hired Flint ten years ago. It has been a very good working relationship for both men. "Carrol is passionate about his horses and continues to raise the quality of his stock to be competitive in Louisiana and out of state," explained Flint. "He spares no expense in their care and feeding program. I oversee the racing division, but everyone on the farm works as a team and shares the same vision."

One of Castille's other goals was to bring a higher level of stallions to stand in Louisiana. He acquired Closing Argument to stand the 2012 breeding season at Whispering Oaks Farm. The son of Successful Appeal won the Holy Bull (G3) prior to competing in the 2005

> Kentucky Derby. His move to Louisiana was very successful, finishing third in earnings in both 2012 and 2013 with \$3.6 million and \$2.99 million.

The current stallion roster at Whispering Oaks includes One Liner, who won the \$500,000 Grade 3. Southwest Stakes at Oaklawn Park and followed that with a runner-up effort in the \$300,000 Grade 3. Pimlico Special. His first crop arrived in 2020.

No Parole joined the roster for the 2022

breeding season. The son of Violence won 6 of his 13 starts and was honored as 2020 Louisiana Thoroughbred Horse of the Year.

"We needed a sprint stallion and have had tremendous interest already in No Parole," said Castille.

Iron Fist was a multiple-stakes winner who banked \$1.1 million in his 24 starts for Hall of Fame trainer

Castille and Asmussen have forged a solid bond. Whispering Oaks Farm owned She's a Julie who was brilliant in her 3-year-old season. She's a Julie was consigned by Blandford Stud and purchased by Whispering Oaks for \$160,000 at the 2016 September Keeneland Yearling Sale.

Her talent played out on a national stage as the filly, named after Steve's wife, Julie, was courageously battling breast cancer.

From 2017-2020, She's a Julie made 21 starts, competing in 14

graded stakes with victories in the G1 La Troienne S. at Churchill Downs, G1 Ogden Phipps Stakes at Belmont Park, G3 Iowa Oaks, G3 Remington Park Oaks, and G3 Bayakoa Stakes and placed in another four graded contests. She earned \$1,196,380 over her lifetime career.

"Carrol is a great guy and excellent horseman," said Asmussen. "He has stayed true to his roots in supporting Louisiana racing and is constantly looking to improve his breeding operation."

Castille has enjoyed the highs and lows of the racing industry, but admits he was disappointed when Un Ojo had to be scratched from this year's Kentucky Derby and Preakness Stakes due to a bruised foot.


The son of Laoban, co-owned by Whispering Oaks Farm and Cypress Creek Equine, lost his left eye due to an accident as a yearling. Despite that setback, the bay gelding, who broke his maiden at Delta Downs, I really felt for Steve that afternoon. In my opinion, Steve is the smartest horseman in the industry and someone I truly enjoy working with."

Partnerships have always been fruitful for Castille, in both racing and breeding. He rises each morning at 4:30 a.m. and thoroughly enjoys nicking the stallions.

"I have teamed with some very high profile people in the industry," admitted Castille. "It's been a great deal of fun!"

Castille has devoted countless hours to supporting the state's racing industry with service as a board member of the Louisiana HBPA as well as a longstanding member of and former board member of the Louisiana Thoroughbred Breeders Association as well as a longtime member of the Louisiana Quarter Horse Breeders Association.

Castille has won leading owner titles at Fair Grounds, Delta Downs and Evangeline Downs and is

hopeful that sports wagering and the addition of Historical Racing Machines will fuel purses in Louisiana.

He acknowledges the dedication of each of his employees at Whispering Oaks. Phyllis Redding has known Castille for 40 years and has been the office and farm manager since 2012.

"He's a great boss and tells me that he doesn't bother me much because I am doing what I'm supposed to do," said Redding

In addition to Flint and Redding, the team includes stallion manager Juan Ramos; Oscar Ramos, who serves as track and property manager; Jesus Gonzalez, who is assigned to the mares and Jose Antonio Rodriguez, who handles the weanlings and yearlings. Dr Stephanie Abbott, DVM is the farm's veterinarian. She is involved in the care and wellness of each of the stallions and broodmares performing pre-and postfoaling services.

Redding shared her pride in welcoming guests to Whispering Oaks Farm.

"Past visitors have called it the Taj Mahal of Louisiana," she said.

Castille would manage a wry smile at that compliment and deflect the recognition to others.

"I am only as good as the people around me," acknowledged Castille. "I've been so blessed to work with people who are passionate and share my vision."

## ALL'S WELL THAT ENDS WELL

After over forty years, Dr. Delmar Caldwell has retired from the thoroughbred industry

Dr. Delmar Caldwell is a man who claims that he must have something to do, and his cup is still overflowing with activity at the age of 86.

His burgeoning resume of accomplishments has continued to expand. Throughout his remarkable lifetime Dr. Caldwell's passion for Thoroughbred racing led to the creation of Double Dam Farm near Folsom and a highly successful Thoroughbred breeding program and racing stable that he trained and managed. He is also a worldrenowned eye surgeon, speaker and professor, the Chairman of the Department of Ophthalmology at Tulane University, a world traveler, judged the Miss Universe contest, a philanthropist, inventor, entrepreneur, author, and athlete—a virtual renaissance man in a time when any one of those endeavors would be considered an outstanding life accomplishment.

How does someone who has been so involved in all that life has to offer suddenly decide to retire from Thoroughbred racing? Not an easy decision, according to Dr. Caldwell, who recently sold Double Dam Farm along with most of the horses and moved to a 30acre farm with his life partner Jo Ann Thompson.

Currently there is only one horse on the new property, 32-year-old Hope List, a homebred favorite who compiled an enviable race record over six seasons with seven stakes victories out of 20 wins, 12 seconds, and 13 third place finishes in 81 starts for earnings of \$601,475. She raced almost exclu-

sively in Louisiana, with a stop at Churchill Downs for the 1997 edition of the Mint Julep Handicap and at Oaklawn Park for the Bayakoa Handicap. Hope List scored three victories in the Red Camelia Handicap at Fair Grounds in 1995, '96 and '97, and two wins in the 1995-96 editions of Louisiana Champions Day Ladies Stakes. For her efforts she was honored as the Louisiana Champion Older Female in 1995 and '96.

"Hope List is a pensioner and family favorite, as was her mother Knightly Spritely, who was formerly a Louisiana Broodmare of the Year," said Dr. Caldwell. "She gave us many exciting memories on the racetrack and winner's circle. Hope List still gallops to the fence every evening for treats and moves like a young horse. It is hard to believe how old she is, but she has certainly held her age well."

"It was a tough decision to sell the farm and the horses," said Thompson, "but Dr. Caldwell's health and my own really depend on it. It was a very emotional time selling the farm and watching the horses leave one-by-one. You have invested your entire life's work in the horses, the farm, and letting go of it all is very hard. Change is difficult, but it is something you must embrace. So many people do not know when to make that change in life-to slow down, scale back. The Thoroughbred racing and breeding business has been very good to us, and it has played an important part in our lives. We are thankful to have been part of it."

Dr. Caldwell purchased the 167 acres of farmland in 1980 that would eventually become Double Dam Farm. Working alongside his brother and two sons they cleared the land, rebuilt the barns and fencing, and eventually built a house. When the farm was completed, Double Dam stood on 137 acres with a 5/8-mile training track, paddocks, mare, stallion, breeding, and training barns. The unique fencing made from old, recycled conveyer belts added an important safety feature to the farm.

"I discovered this type of fencing in South America," said Dr. Caldwell. "If a horse ran into the fencing, there was no way that they could get hurt as was common with the regular four-board fencing."

Dr. Caldwell has always had a passion for horses from childhood. He started climbing aboard the horses at the ranch where his uncle worked at the age of 5. They were crusty old ranch horses who would have rather been left alone during their off time rather than pack around the little boy perched on their backs.

"My uncle worked at a ranch, and I used to tag along," Dr. Caldwell reminisced. "I did not know any different and used to ride those ranch horses without a saddle or bridle. Those old horses were as tough as hickory, real working horses; that was their primary purpose. They were kind of grumpy horses... probably because of how much they worked. There was nothing pampered about them."

Shortly after learning to ride, Dr. Caldwell's carefree childhood came to an end. His father had passed away, and shortly thereafter his mother died from complications following gall bladder surgery. Dr. Caldwell and his siblings found themselves suddenly orphaned. He can remember being so hungry that he made soup out of catsup.

"It was a very difficult time, but we managed." said Dr. Caldwell. "Eventually I was taken in by a German family who owned a ranch. One of my primary duties was to round up the cattle and keep an eye on them. I can remember bathing in the water tank, eating Spam in a can, and sleeping under the stars. Delightful at the time. Just me, the horse, and the great outdoors."

Despite the circumstances that shaped his early life Dr. Caldwell revealed early that he was gifted academically and athleticallywith a great deal of character and moxie. During his high school years, he lettered in basketball, baseball, and football. At the age of 18 he was a minor league first baseman for the former Washington Senators traveling around the country in a dilapidated old bus that was so hot "you could cook an egg on the seats". He also became the class president, a straight A student, all while working odd jobs.

At age 14, he drove a wheat truck to Canada from North Dakota. One summer, the truck broke down, and there was no way to move the wheat. Dr. Caldwell was without a job and needed the money for the coming school year. It was going to take some ingenuity to figure out a way to move that wheat.

"I figured if I raised some hogs, sold them, and bought a truck then I could move that wheat to Canada and have a job every year," said Dr. Caldwell. "The only problem was I did not have a job, and no money to buy the hogs, so I went to the bank to get a loan. The bank president asked me if I had any collateral and I asked him 'What's collateral?' He explained it to me, and I told him that I didn't have any collateral. He asked if I knew of anyone who would vouch for my character on the loan, and I suggested the high school teachers and principal. Well, I ended up getting the loan and the bank president co-signed for me. I bought the hogs, and eventually sold them. I bought the truck so we could transport wheat every year and we all had our jobs back."

The University of Oklahoma offered Dr. Caldwell a full football scholarship and his academic future was looking bright. During medical school, Dr. Caldwell and his new wife found a way to make ends meet. They rented an old threestory mansion and had a daycare on the first floor for medical students' families and rented out the third story ballroom to fraternities and sororities for parties.

"Back then we did anything to make a buck," said Dr. Caldwell, "and we got very creative. I only made \$38 a month as an intern, so we had to figure out how to make extra cash to pay the bills. We had this huge old mansion that we rented and made the best use of the space."

Dr. Caldwell's graduation from medical school led to additional education at Texas, Harvard, and Baylor. Highly regarded by his peers, he accepted a position as the Chairman of the Department of Ophthalmology at Tulane in 1978 which he held until two years ago. Currently he still teaches and lectures several days a week. Dr. Caldwell's expertise as a noted specialist in cornea, anterior segment, and glaucoma surgery had led him to help people on mission trips throughout the world, mainly in

South America. His work led to the creation of an artificial cornea called the Caldwell Keratoprosthesis.

"It is very humbling and gratifying to be able to help so many people and make a difference in their life," noted Dr. Caldwell. "People would line up out the door for days waiting for surgery. It was the packing up and leaving that was so hard to deal with. Heartbreaking really. You wish that you could help them all."

At one time Double Dam stood six stallions including Royal Strand (Ire), List, and El Mandingo. My Friend Max, a son of Danzig, was a stallion that Dr. Caldwell acquired in a most unusual way.

"An old friend named John Clark told me about a well-bred son of Danzig running loose on the beach down in Panama," said Dr. Caldwell. "Clark said that Danzig was going to be a big deal and I needed a son of his. I went down to Panama to see the horse. Sure enough, I found him running on the beach with a band of mares and decided to bring him back. He ended up siring some very good horses for us." Double Dam Farm has bred multiple stakes winners over the years but many of the most successful runners were produced out of Knightly Spritely who was given to Dr. Caldwell after her former owner discovered that she did not sweat. Dr. Caldwell had a special air-conditioned stall built for the mare, which helped to keep her cool during the summer.

In addition to Hope List, Knightly Spritely produced multiple stakes winner and Louisiana Champion Three-Year-Old filly Knight Woman, who earned \$515,376, and multiple stakes winner Knight Man, who retired with earnings of \$279,785. Another Double Dam homebred stakes winner, Costa Rising, retired with earnings of \$901,616 and won the 2007 edition of the Louisiana Champions Day Classic Stakes among his notable victories.

"We have been blessed with some very exciting moments in the sport of horse racing," said Dr. Caldwell. "The trophies, photos and memorabilia line the walls and remind us of every day just how thankful we are.



## **HORSE HEALTH**

#### LEG CONFORMATION INFLUENCES RACING ABILITY AND SOUNDNESS

Then evaluating potential **V** racehorses and selecting prospects at yearling sales, conformation is one of the main things buyers look at. Conformation of feet and legs helps determine a horse's athletic ability and speed, and plays a crucial role in whether or not he will hold up under strenuous use. Feet must be strong and of adequate size for body weight. Front legs should be as close to ideal conformation as possible to minimize concussion, since they bear about 2/3 of the horse's weight.

Since racehorses start training young, stress on immature bones and joints can cause breakdown and unsoundness if faults create uneven weight bearing. The front legs support most of the weight, absorb the shock of concussion and lift the body for the "flight" phase of each stride. Hind legs suffer less concussion but play a major role in how the horse travels, whether he'll have limb interference. whether he'll be fast or slow or suffer from stifle or hock problems. The main function of the hind limbs is to provide most of the power and propulsion for forward movement.

#### **FRONT LEGS**

The forelimbs help in pulling the horse along at all gaits, and also help determine length of stride. Strongest front leg construction consists of straight legs with sturdy bone structure, big flat knees and deep, well-shaped fetlock joints. Ideally the front legs should be straight when viewed from the front or side, forming a right angle to the ground. Toes should point to the front and feet should be the same distance apart as the distance between the forearms where they come out of the chest.

A horse with crooked front legs may develop splints or joint problems. A splay-footed horse may strike himself. He may fracture the inner sesamoid bones on the fetlock joints due to additional stress on these bones. A pigeon-toed horse may injure the outer sesamoid bones or suspensory ligament.

Looking at the leg from the side, a calf kneed horse (back at the knee) has a lot of stress on knee joints and may develop chip fractures. A calf-kneed horse is also slower breaking out of the starting gate because his weight is more toward the rear of the foot. Over at the knees (buck kneed) is stronger construction than calf knees, and many good racehorses are slightly over at the knee.

Pastern and hoof angles are important. The pastern/hoof should not be too sloping or pasterns will be weak; the fetlock joint may go clear to the ground when the horse is tiring during a long race. Conversely, if the pastern does not slope enough, there won't be enough "give" when weight is placed on the leg, and the increased concussion will likely damage the feet and legs and may lead to navicular disease. If the pastern slopes adequately, it transfers some of the weight to the tendons and their attached muscles on the upper leg, which have some elasticity. Proper pastern slope (about 50 degrees) makes less risk for sore shins, damaged knees, or tendon strain. A horse with shallow heels and long toes may suffer chip fractures in the knees or bowed tendons because of the extra strain on knee bones and tendons during exertion.

For strongest construction, looking at the leg from the front, it should be straight or very slightly in at the knee. Weakest construction is out at the knee.

Studies by Dr. Wayne McIlwraith and colleagues at Colorado State University about 18 years ago showed that racing Thoroughbreds with a slight inward angle at the knees (knees slightly closer together than the fetlock joints) suffered fewer knee injuries than horses with perfectly straight legs.

These researchers felt this was due to decreased weight bearing on the inside knee joint, where most chip fractures and arthritis incidents occur. If the cannon bone is angled slightly (in at the knee) some of the load is taken off the inside portion of the knee.

In contrast, if a horse is out at the knee (bowlegged, with knees farther apart than the fetlock joints), he rarely stays sound. If fetlock joints and feet are closer together than the knees, there is enormous stress on the inner portion of the knee joint.

For speed, a horse needs proper leg and body angles to facilitate freedom of leg movement and a long stride. In other words he needs well-sloped shoulders and an acute angle in shoulders and hips. A well-laid back shoulder that's not overburdened with heavy muscle enables the front leg to swing forward and back farther, most quickly. Long forearms and short cannons also help increase the leverage action of the front legs.

#### HIND LEGS

Viewed from the rear when standing squarely, hind legs should be straight-from buttock to hoof. All joints should be in a straight line; a line dropped from the point of the buttock (or drawn with a straight-edge on a photo of the horse) should bisect the leg, going down through the center of the hock, cannon, fetlock joint, pastern and hoof. The stifle joint may be slightly rotated out and the hock slightly rotated inward (and the toes pointing slightly outward) yet the line should still bisect the leg. This is the strongest and most well-balanced construction, giving best support to the whole leg.

An athletic horse needs plenty of width between the stifles, which means they should be pointing slightly outward (with toes pointing outward to the same degree).

In a horse with feet facing perfectly forward, there is some stress on the outside of the foot and leg which can lead to lameness if the horse is worked hard. Weakest construction is "out at the hocks" (bowlegged) with the toes pointing inward. The leg wobbles outward at the hock at every stride and the horse may also be base narrow (fetlock joints too close together). This structure is most common in heavily muscled horses; the hindquarters are wide with leg bones too far apart at the top but coming closer together toward the ground. This puts extra strain on the outside portions of the legs, joints and hoofs. The hind leg doesn't have much forward reach, with a lot of wasted motion caused by twisting of the hock as the foot is lifted from the ground.

At the opposite extreme is the base wide horse (cow hocked and splay footed). The hocks are too close together and the feet too wide apart. This puts stress on the inside of the joints.

Many horses with this conformation tend to hit themselves because when the toed-out foot is picked up it folds inward instead of traveling straight. The hoof may hit the opposite cannon bone. There may also be some contact between front and rear limbs when running hard; the horse may whack his hocks with the front feet when the front legs are being picked up as the hind feet move up alongside them.

When viewed from the side, the cannon should be vertical and directly under the buttocks. A line dropped from the buttock should touch the point of the hock and follow the back of the cannon down to the back of the fetlock joint, hitting the ground a short distance behind the heel of the foot. This creates ideal angle in the hock.

If the hock joint is too straight (post legged, set too far under the buttocks toward the belly) or too angled (sickle hocks, hock and cannon slanted and not perpendicular to the ground), there is always more stress on joints. The sickle-hocked horse is more likely to develop curb (enlargement of the tendon at the back of the hock, due to strain and tearing of the tendon), bog spavin (permanent swelling in the soft tissues of the hock) and may also damage the bottom or back of his hind fetlock joints when running hard.

The longest stride is attained if the hind legs can straighten fully, without any wasted motion. Many of the best racehorses have a relatively level rump and moderate hock and stifle angles to allow the hind leg to swing freely like a pendulum. If the hocks and stifles are too bent (too much angle, sickle hocks) there's some loss of time in straightening out the joints at each stride. There is more circular motion before the hock can get into position to drive the horse's body forward. A straighter leg can swing farther and faster, beginning forward motion from the point of the toe with no loss of motion between the ground and the top of the hock.

Because of this factor, some breeders select for relatively straight hocks and stifles (post legged) because the straighter leg can swing faster. But if joints are too straight, this can lead to slipped patella (and locked stifles) and damage to the stifle joint and also more stress on parts of the hock joint.

For optimum leverage and speed, the thigh bone (tibia) between stifle and hock should be relatively short, with a longer cannon for more pushing leverage. Some sprinters have long hind legs (putting the croup higher than the withers) but this can lead to overreaching and injury to the front legs unless the horse has a relatively long back or travels wide with the hind legs.

Perfect conformation won't make a winner, however; the horse must also have a good engine (strong heart and lungs, for stamina) and a lot of heart (desire to win). It's not always easy to determine which horse will hold up under hard work and which one might break down. Some horses have poor conformation and make up for it with strong joints and structural integrity (exceptional strength of the stay apparatus: muscles, tendons and ligaments).

There is more to success than ideal conformation, but it certainly helps tip the odds toward maximum speed and longevity.



#### **RACING NEWS**

#### Louisiana, West Virginia Granted Injunction Against HISA

Louisiana Attorney General Jeff Landry has won a victory over regulations imposed by an unconditional and unfunded Congressional mandate that cedes much regulatory and taxation power of the State to an unelected and unaccountable nongovernmental entity.

Ruling in favor of Attorney General Landry – Judge Terry Doughty of United States District Court in the Western District of Louisiana has granted the State of Louisiana, State of West Virginia, Louisiana State Racing Commission. Louisiana Horseman's Benevolent & Protective Association, Louisiana Thoroughbred Breeders Association, Jockeys Guild, West Virginia Racing Commission, and horse owners, trainers, and jockeys a preliminary injunction against rules created from the Horseracing Integrity & Safety Act of 2021 (HISA).

"I am grateful Judge Doughty applied the law and blocked this federal overreach from devastating our State and the thousands of Louisianans in the horse industry here," said Attorney General Landry. "Since becoming a State in 1812, Louisiana has not only regulated horseracing but also built an entire culture around it with the owners, trainers, jockeys, racetracks, and patrons."

She is also survived by an extended host of family and friends. ly set up this massive regulatory scheme that is onerous at best on everyone; then to add insult to injury, it is paid for on the backs of those who work the hardest and receive the least," explained Attorney General Landry.

As noted when Attorney General Landry filed suit in June – HISA purports to effectively substitute state regulatory commissions with a private corporation, setup 90 days prior to the passage of this Act, in charge of horseracing. This newlycreated private corporation then began to issue regulations – allowing very little time for public comment, leaving those that actually labor under them with little input or voice.

"The process of creating the law and its associated regulations showed a reckless disregard for the thousands of industry participants in Louisiana and a correspondingly reckless disregard for the impact to our State," added Attorney General Landry. "The regulations are unclear, inconsistent, and violate due process; and I will continue to do all that I legally can to halt them from taking effect in Louisiana."

#### Louisiana Commissioners Lengthen Penalties For Trainers In Zilpaterol Cases

Racing commissioners in Louisiana took penalties for zilpaterol overages one step farther in a lengthy meeting April 26, extending the already significant suspensions handed out by stewards a few weeks earlier.

The commission considered eight positives from trainer Rosendo Valdez, four from Lanny Keith, four from Manuel Pizana, three from Manuel Macias, and two from Fernando Lopez. The overages were part of a flood of recent zilpaterol positives in the state.

Zilpaterol is not approved by the Food and Drug Administration (FDA) for use in horses. Instead, it is a drug approved for use in beef cattle to promote weight gain and lean muscle mass. It's commonly administered as a feed-through product when given to cows.

Zilpaterol is a Class 2 drug in the Association of Racing Commissioners International guidelines and is not considered to have any legitimate therapeutic purposes in the horse. According to Dr. Levant Dirikolu, head of the equine drug testing laboratory at Louisiana State University, it is closely related to clenbuterol and ractopamine.

Stewards had already given each licensee a six-month suspension per violation, which was the maxi-

mum available to them by Louisiana regulations. The commissioners voted to extend those penalties in every case.

The commission unanimously agreed to extend the eight suspensions before them for Valdez from six months each to one year each, and increase the fine to \$1,500 for each one.

The remaining trainers were represented by attorneys, and all said they received notice of all their zilpaterol positives at the same time, so had no opportunity to change barn management or scratch horses in response to the issue.

#### Lifetime Bans Upheld for Patin Brothers

The Louisiana State Racing Commission (LSRC) affirmed lifetime bans for two sibling jockeys from the Patin family on April 26th related to the brothers' criminal convictions for possessing illegal horse-shocking devices in races at Evangeline Downs in 2015.

The hearings concluded in bizarre fashion when Joseph Patin Jr., 58, apparently slipped out of the meeting room without telling anyone after first hearing that his younger brother, Billy Patin, 53, wasn't going to be allowed to work as an exercise rider despite Billy previously agreeing to a lifetime ban of his license as a jockey.

The Patins are no strangers to brushes with the law and racing infractions.

After a 30-1 win by the maiden Valhol in the 1999 Arkansas Derby, Billy Patin served a five-year suspension after a video showed him dropping an electrical item that was later recovered on the track at Oaklawn Park.

Joe Patin's riding career was

interrupted several times by lengthy suspensions and arrests related to narcotics abuse. In 2013, he was escorted from Evangeline in handcuffs after an altercation with jockey Diego Saenz.

In 2015, the two Patin brothers were arrested by Louisiana State Police and charged with "willful pulling of the reins and cheating and swindling" in relation to a June 19 race. Later, the Patin brothers were additionally charged with "unnatural stimulation of horses" related to separate incidents July 4.

According to evidence read into the record at the Apr. 26 LSRC commission, the race-fixing charges were later dropped by the prosecutor, but the charges related to the shocking device resulted in felony convictions for the Patin brothers. "Evidence in two separate races on July 4, 2015, revealed that the [Patins] possessed hand held shocking devices," a state police press release had stated at the time of the arrests.


Initially, the commission-level adjudication of the Patin brothers' licensure came up at the January 2022 LSRC meeting.

At that time, Billy agreed to a lifetime ban as a jockey. But, having already completed his probation and having received a firsttime-offender pardon, he wanted the commission's approval to go back to work as an exercise rider. That request was tabled until April's meeting, as was the entire matter of Joe's jockey license adjudication.

Joe who was originally in attendence dissapeared from the meeting room. Without Joe Patin being in the room to answer to the allegations, the LSRC voted unanimously to give him the same lifetime ban as a jockey.

#### Louisiana Downs Announces Return Of Super Derby In 2023

Louisiana Downs announced that the Super Derby will be postpoed for one year, but will return in 2023. An August 15th press release stated, "With support of our horsemen the return of Super Derby is being postponed until 2023. This move will allow us to realize the benefit of adding revenue from the Historical Horse Racing machines, the additional Off Track Betting locations, and sportsbook that will contribute to the purse structure. Additionally, we are adding over



one hundred new slot machines to the casino floor which will increase our slot revenue therefore enhancing our future purse structure. We truly want to position this special race to be nationally recognized and better support our local horsemen who support our track by choosing to race here. We want to highlight Louisiana Downs in the best way possible and ensure we can provide a unique experience to guests whether it be for the first time or for a return visit. We invite you out to experience the track if you haven't joined us recently and we look forward to the remainder of the season. With construction beginning next week on our restaurant offerings and additional improvements continuing at the racetrack, we are working to put Louisiana Downs back on the map. While we have already announced some exciting changes, there is more to come! We want to make sure we are putting Louisiana Downs in the best possible position for growth, which is why postponing this event is the best decision at this time."

"I came to Louisiana Downs in the middle of July and with figures from accounting we decided to lower the overnight purse distribution for our 5th condition book with all intentions of getting back up for condition book in the last September. That being said, my recommendation was to not run Super Derby this season. We have serious plans to bring back our premier race in 2023 with hopes of attracting an outstanding field for the race," said Matt Crawford, Louisiana Downs Racing Secretary

#### Oaklawn Adds 9 Stakes To 2022-23 Schedule

Although it doesn't begin until Friday, December 9, the 2022-2023 Oaklawn racing season has already broken at least two records. The Hot Springs, AR, track will offer the greatest number of stakes races and the highest stakes purses in its history.

Nine races have been added to the stakes schedule for the 68-day season, bringing the total to 45. Total purses offered for the stakes program have increased by \$1.45 million to an all-time high of \$13.75 million. The overall purse distribution for the season is projected to exceed \$50 million, yet another record.

The stakes schedule is once again highlighted by the \$1.25 million Arkansas Derby (G1) April 1, along with three \$1 million stakes races – the Rebel Stakes (G2) February 25, the Apple Blossom Handicap (G1) April 15, and the Oaklawn Handicap (G2) April 22.

This is the second consecutive season Oaklawn is opening in December. Oaklawn President Louis Cella said the expansion of the stakes program is made possible by the early start. "We were pleased with how December racing was received last year, by both racing fans and horsemen," Cella said. "Now, we're going to use our stakes schedule to build on that momentum."

Three of the new Stakes races are scheduled for December, while the other six will take place during the final weeks of the season.

"One of the reasons Oaklawn has been successful for more than a century is because of where we are located," Oaklawn General Manager Wayne Smith said. "Tourism is a major industry in our area, and Oaklawn is proud to be the state's top tourism attraction. We wanted some stakes with names synonymous with Oaklawn's hometown and the surrounding area."

The 2022-2023 season runs Friday, December 9 through Saturday, May 6, Kentucky Derby Day.

#### 2022 Belmont Park Fall meet to be held at Aqueduct Racetrack

The New York Racing Association, Inc. (NYRA) has announced that, due to the construction of vehicular and pedestrian tunnels designed to provide access to the Belmont Park infield, the 2022 Belmont Park fall meet will be held at Aqueduct Racetrack.

The 28-day Belmont at the Big A fall meet will begin on Thursday, September 15 and run through Sunday, October 30. Headlined by four Grade 1 races and six "Win and You're In" qualifiers to the Breeders' Cup in November at Keeneland, Belmont at the Big A will feature 23 graded events among 41 stakes worth \$9.9 million in total purses. Live racing will be conducted Thursday-Sunday.

The construction of tunnels for vehicular and pedestrian access is a major capital improvement project that will unlock the 45-acre infield at Belmont Park. In addition to providing access for fans and the surrounding community, the tunnels will serve as a conduit to the infield for commercial vehicles allowing NYRA to completely reconstruct the Belmont main track and its two turf courses. The tunnels will also provide NYRA with the opportunity to consider the installation of a synthetic track in the future.

NYRA expects main track and turf training to resume in April 2023. Construction on the racetracks will begin following the conclusion of the 2023 Belmont Park spring/summer meet, which will be held in its entirety at Belmont.

Following a three-week closure for annual track maintenance, the Belmont Park training track will reopen on Monday, August 8 and remain open throughout tunnel and track construction.

As part of the same round of capital improvement projects, NYRA will install a synthetic surface on the <sup>1</sup>/<sub>4</sub> mile Belmont Park Pony Track. Expected to be complete in September, the Tapeta Footings track will provide a new all-weather training option and yield information and data on the performance of a synthetic surface in the weather conditions at Belmont.

The Oklahoma Training track will operate as normal, with scheduled turf training available throughout the fall.

#### DHS and DOL Announce Additional H-2B Visas for 2022

The National Thoroughbred Racing Association (NTRA) commends the decision announced by the Departments of Homeland Security (DHS) and Labor (DOL) to make an additional 35,000 H-2B visas available for the second half of FY-2022.

"We thank DHS, DOL, and the Administration for recognizing the critical need for additional H-2B visas to fill positions not being filled by US workers," said NTRA President & CEO Tom Rooney. "This announcement will help provide immediate relief for tracks and horse trainers going into the summer racing season. While the release of additional H-2B visas is good news for the industry, the NTRA will continue to advocate for more comprehensive immigration reform in the future."

The supplemental H-2B visa allocation is for U.S. employers seeking to employ additional workers on or after April 1, 2022 through September 30, 2022. This announcement makes 23,500 visas available to returning workers who received an H-2B visa or were otherwise granted H-2B status during one of the last three fiscal years. The remaining 11,500 visas are reserved for nationals of El Salvador, Guatemala, Honduras, and Haiti, regardless of whether they are returning workers. The semiannual cap of 33,000 visas for the second half of FY 2022 was reached on February 25, 2022. Employers can begin petitioning on Wednesday, May 18.

The H-2B visa guest worker program is a nonimmigrant visa program used by many industries that need temporary non-agricultural help when domestic workers are unavailable. For the horse racing industry, trainers rely heavily on the H-2B program to fill various backside positions.

#### 2022 Claiming Crown Will Be at Churchill Downs

The 2022 Claiming Crown will be held at Churchill Downs in November, according to Dan Metzger, president of the Thoroughbred Owners and Breeders Association.

Speaking on Horse Racing Radio Network's Equine Forum June 4, National Horsemen's Benevolent and Protective Association CEO Eric Hamelback first announced the news, saying: "I am over the moon excited to move the Claiming Crown for 2022 to Churchill Downs. Saturday, Nov. 12 is the plan for now. We are appreciative of Churchill Downs, especially to (track representatives) Mike Ziegler and Ben Huffman who wanted this event. We are hoping for as spectacular a day as we have had at Gulfstream over the past years. The long-term plan is to stay within the Churchill Downs family, going to Louisiana (Fair Grounds Race Course & Slots) for 2023."

Representing a partnership between the National HBPA and TOBA, the Claiming Crown acts as a mini "Breeders' Cup" for owners of claiming horses.

This year will be the 24th running of the event as well as the first time it has moved in the last 10 years. Gulfstream Park has hosted it since 2012. In 2013, Gulfstream became the first track to host it consecutively since Canterbury Park, thus beginning a longer-term commitment to host. Canterbury hosted the inaugural Claiming Crown in 1999 and continued to do so for the next 10 years.

The event has also been held at Parx Racing (2002), Ellis Park (2007), and Fair Grounds (2011).

Showcasing some of the most competitive fields in the country, all claiming horses are eligible to race regardless of where they were bred or previously raced as well as the level at which their stable competes.

Consisting of nine races worth \$1.1 million in purses, the Claiming Crown has become a highlight on the racing calendar for

horses who have started for claiming tags between \$7,500 and \$35,000.

Warren Harang called the meeting to order and asked Roger Heitzmann to call the roll. A quorum was present with Michelle LaVoice, Michele Rodriguez, Keith Hernandez, and Jim Montgomery absent. The meeting was ready to proceed with business.

Jake Delhomme led us in prayer.

Warren Harang asked Therese and Greg to present the audit report. Greg explained the annual audit of financial statements to the board and explained the impact of Covid on the race revenue from the 2020 year, as well as our beneficial 2021 year as Covid calmed down. They spoke about the paycheck protection enforced in 2020. Greg asked if anyone had questions. With no oppositional votes from the board Warren declared the motion carried and to move on with the meeting.

Warren requested the approval of the minutes from the meeting of the Board on April 12, 2022. Roger stated that two corrections had been made to the minutes from said meeting regarding the correction of two members' names. Tom Early made a motion to approve the minutes with these corrections made by Roger. Brett Brinkman seconded this motion which was voted on and passed unanimously.

Next on the agenda is the updating of conflict of interest forms. Warren asked for any members who needed to make revisions from their old forms to submit them.

Moving forward with the agenda was the Ladies Race on Louisiana Champions Day. Roger announced that he had received a letter from Mr. Scott Jones, the Fair Grounds Racing Secretary, asking to please let him know if it was decided whether the Ladies Race would run on dirt or revert back to turf. Roger stated that the Fairgrounds would prefer the race be moved back onto turf for the sake of entry numbers. After discussion ensued over other races being run on turf or dirt and the pros and cons of such, Warren asked the board to vote on the decision of turf vs. dirt for the Ladies Race on LA Champions Day. Jake Delhomme made a motion to have it run on turf for this year. Tom Early seconded this motion which was voted on and passed unanimously.

Warren announced the next item on the agenda was a discussion regarding HISA. Warren announced that a HISA representative will be present at a meeting being held at Evangeline Downs to answer any questions and clear up any confusion. Discussion ensued over HISA, how the Board feels regarding it, and how multiple members have called to report how they feel regarding it. Roger announced that many members have told him they are not registering, or some are waiting to register because they do not truly understand what HISA is about as well as its requirements. Charlotte Clavier explained how most people are worried they would be signing over their rights to have their private property searched and possessions seized at any time, which would all be public knowledge and not kept private. Warren reminded that there are different rules regarding homes vs. farms with HISA. Charlotte countered that, like many others, her house is also her farm and therefore are one in the same in the eyes of HISA. Warren stated that tracks have different rules than farms; for example, if you live hours away from the nearest veterinarian you are allowed to have some medications on your farm. However, on a track, which would have an onsite veterinarian, you may not have these medications as they are not deemed necessary since there is already a licensed vet on the grounds. Further discussion ensued over the changing terms and conditions, which has added to the confusion regarding the requirements of HISA, as well as who will be affected by HISA once in place. Roger stated HISA is federal law that will go into effect as of July 1st, 2022. Warren

announced that moving forward he wants every member of the board to reacquaint themselves with the HISA requirements, as they continue to change.

Moving on with the agenda, Warren asked Roger to discuss the Memberships and Election. Roger reminded the board that until the board decides on the definition of a member, and said by-laws regarding membership, that the LTBA cannot send out membership forms this month to its members. He also stated that this means there will be no election at this time either until further notice. Roger announced that a draft of new by-laws has been drawn up by attorney John Duvieilh and this has been sent to the By-Law committee for review. Roger stated that each member present has a copy of the draft in their folders and reminded them that this was just a draft; the committee is still open to suggestions, concerns, or changes regarding said draft of the by-laws. He announced that you may now apply for a 3-year partnership license as opposed to the previous only 1-year license. Roger stated that the sports books may now also take horse bets as well.

Warren Harang called the meeting to order and asked Roger Heitzmann to call the roll. A quorum was present with Jay Adcock and Michele Rodriguez being absent. The meeting was ready to proceed with business.

Jake Delhomme led us in prayer.

Roger Heitzmann cited a correction for the minutes of the last board meeting. Roger asked if there were any further corrections to be made, there were none. Warren requested approval for the meeting of the Board on February 4, 2022. Tom Early motioned to approve the minutes of the February 4, 2022 Board Meeting. Charlotte Clavier seconded the motion which was voted on and passed unanimously.

Warren requested approval for the minutes from the March 10th Special Meeting. Tom Early motioned to approve the minutes of the March 10, 2022 Special Meeting. Michelle LaVoice seconded the motion, which was voted on and passed unanimously.

The next item on the agenda was voting on Horse of the Year. All board members turned in their ballots and Roger announced that the Louisiana Thoroughbred Horse of the Year award would go to Cilla. The meeting was ready to proceed forward.

The next item was voting on the TOBA representative. Roger reiterated the purpose of the TOBA representative. All members turned in their ballots and the meeting was ready to proceed forward.

Roger announced for the record that Jake Delhomme has submitted his updated conflicts of interest and is doing business with Val Murrell, Charlotte Clavier, Clear Creek Stud, and Adcock River Farms as well as purchased a stallion share in Strike Power. Next item on the agenda was the Mare Purchase program. Danny Guidry proceeded to discuss the importance of the program and how its purpose is to encourage purchasing and breeding of Louisiana thoroughbreds. Further discussion ensued on the financial funding of the program. Danny presented to the board the idea that a percentage of the purchase price of a mare, not private sales but from a venue, be paid back to the purchaser only if said mare becomes a resident mare that is bred back to a Louisiana stallion. This would allow for a bigger pool of mares for Louisiana stallions to breed with. A discussion began over what qualifications would be necessary as well as what certifications said purchaser must provide to qualify and whether or not the program would be on a "first come first serve" basis based upon the funding provided. It was decided to readdress this program idea in the August board meeting after the fiscal year has ended and funding information has become available.

Warren introduced the guests of the board meeting and passed the floor to Joel Robideaux. Joel informed every one of the bills progressing and current movement within the committee. He also spoke on the progress of Historical Racing Machines and Sports Betting.

Warren passed the floor to Mary McFadden and thanked her for her and her late husband's, Neal McFadden, years of service in the breeding industry. Warren presented Mary with a memento for her keeping. Mary thanked the board and spoke briefly about Neal.

Warren Harang called the meeting to order and asked Roger Heitzmann to call the roll. A quorum was present with Jake Delhomme being absent. The meeting was ready to proceed on with business.

Charlotte Clavier led us in prayer.

Warren Harang III requested the approval of the minutes of the meeting held on December 12, 2021. Val Murrell made a motion to approve the minutes as presented. This motion was seconded by Michelle LaVoice, which was voted on and passed unanimously.

Mr. Lane Cortez, a member of the Louisiana Racing Commission, is present today to discuss the proposed rule changes that are being worked on by the Commission. Lane started by saying that he was invited by Roger Heitzmann to speak specifically on the caps rule (purses) being proposed before the HISA caps rule comes in. With that being said HISA recently dropped that rule on purse caps but have been petitioned to put it back by several horse organizations, specifically California and Mid-Atlantic.

Lane stressed that if it's capped at a level below what we can accommodate with purse incentives for Louisiana Breds, our Louisiana Breds will not be seeing the monies that we have to give them through these incentives.

Lane explained that the horsemen understand how this cap will help horsemen, especially at the lower level. Brett Brinkman explained to the board how this will help the persons with the lower claimers as well as the higher claimers. He explained a better division of purses helps keep someone from stealing the purses at the lower level by gathering up many of the horses at a lower level or a level just above to dominate the higher percentage of purses. He also explained how this would help upcoming sales for the breeders.

Michele Rodriguez arrived for the meeting.

Lane then spoke on the adjustment of the bottom claiming prices and purses payouts on both winners and maidens and how it would work with the caps in place. The whole idea is to help the horsemen not hurt them.

He spoke on how the Racing Commission is working on trying to keep the number of race days while trying to eliminate as much as the overlapping as possible.

Warren brought the question of Louisiana Bred races for Accredited Louisiana Bred horses that are sired by Louisiana Stallions. Lane agreed with Warren that he believed this is doable; however, he understands it can't be added and also draw away from some Louisiana Bred races filling. He stated that this was a concern of the racing secretaries.

John Duvieilh suggested that we take some of the monies from video poker that hasn't been appointed yet to form a bonus purse for horses that have been sired by Louisiana Stallions who have won or placed in races. John suggested that a Purse Supplement Committee be appointed to oversee the distribution of purse supplements in the future. Warren appointed John to the Chair of that Committee. Michele Rodriguez and Charlotte Clavier also said that they would like to be on that committee.

Michele Rodrigue wanted everyone to know that she was against any capping of any purses at any level.

Roger requested to the board that we have a stance when it comes to the work being done by the Racing Commission. We need to get in front of this and not work from behind. Brett agreed that if it gets out of control we won't be able to reel it back in. Lane agreed that we need to be pro active; doing nothing will not be the correct path to follow.

Warren thanked Eddie Delahoussaye for coming to the meeting as well as hearing us as a member of the Racing Commission.

Michelle Rodriguez questioned Eddie on the new popper being introduced.

Eddie explained some of the new rules on the use of the whip.

Warren moved to the next item on the agenda, the Annual Awards Banquet. Roger asked for input from the board. Charlotte Clavier asked if the Breeders Association would once again sponsor a co banquet with R.E.A.P. No motion was made, however everyone agreed that this was a good idea, and Roger and Charlotte would get together to set a date and see that it is planned as a co banquet.

Having skipped an item, Warren asked Roger to explain the redistribution of purse from 7/4/15. Roger proceeded that the office received a purse redistribution from a race held back on 7/4/2015. We were told that the purse was being withheld due to a race fixing investigation. With the party now pleading guilty, the winner will be disqualified and the purse would be redistributed. The problem emulates from the fact that the Association never received anything that notified us that the purse was being withheld.

After discussion and a recommendation from Roger that we not try to go back seven years to collect monies that has been spent and taxes paid on, Brett Brinkman made a motion that we move forward and consider this an uncollectable mistake. This motion was seconded by Michelle LaVoice. With a roll call vote all were in favor with one abstaining.

Brett then made a motion that we send a letter to the Racing Commission explaining our unhappiness with the situation and that we hope this never happens again. This motion was seconded by Michele LaVoice, which was voted on and passed unanimously.
